**Recommendation**: When taking the floor for a contest, teams should take the shortest path to their own side of the court and not run through the area occupied by the opposing team, where the opponents are warming up, or split into two lines and circle their opponents. Where possible, teams should only enter, jog or warm-up on their own half of the court.
