2017 IESA CROSS COUNTRY ADVISORY MEETING Minutes and Recommendations November 13, 2017

The IESA Cross Country Advisory Committee, in its meeting on November 13, 2017, makes the following recommendations to the IESA Board of Directors for their January 19, 2018, meeting:

Recommendation 1- By-laws and Terms and Conditions

Current	The IESA Office will assign IHSA licensed starters for each sectional. Payment to sectional starter is \$50.00.
Proposed	The IESA Office will assign an IHSA licensed girls starter/referee and a boys starter/referee for each sectional. Payment to each starter/referee is \$50.00.
Rationale	An additional official would allow for a more efficient flow of the meet. As one official was verifying the finish the other official could be checking in the athletes for the next race. Not all meets have a common start/finish area. This would also allow coverage of a race if an issue needed to be addressed.

Current	None
Proposed	A minimum of forty-five (45) minutes will be scheduled between race start times at the Sectional meet. This may be adjusted the day of the meet by the meet officials for weather situations.
Rationale	The 45 minutes between race start times mirrors the state meet schedule. It allows for the official to verify the finish line results and any necessary video review. It also allows single coaches the opportunity to conclude coaching one team before attending to their second team.

Proposed	At all Sectional Meets, bibs are required. Bibs must be positioned high on the front of the chest. Bibs
	should be white with dark numerals.
Rationale	Bibs make identification of runners easier for finish line personnel and for video review. (Bibs are about \$50 for 200.)

Recommendation 4- Terms and Conditions

Current None

Proposed	Once the race has started, there will be no disqualification for an improper uniform (unless the uniform is altered after being approved at the starting line by an official). It is the responsibility of the clerk of the course and or the referee/starter to inspect each competitor's uniform prior to the start of a race. They are not to allow a runner to compete in an illegal uniform. If the clerk is unsure of the uniforms compliance with the rules, they will request a ruling from the referee/starter prior to the start of the race. Any runner that alters their uniform after being approved by a clerk of the course will be disqualified for unsporting conduct (this would include but not be limited to, rolling the top up which could expose the midriff).
Rationale	This is the wording that is included in the IHSA Terms and Conditions. IESA Cross Country has been operating under these interpretations and would like to move it to our Terms and Conditions for coaches and officials to reference.

Recommendation 5- Terms and Conditions and By-laws

Current	There will be nine (9) Class 1A sectionals, nine (9) Class 2A sectionals, and nine (9) Class 3A sectionals.
Proposed	The first, second, and third-place sectional teams plus the top five individuals not on the first, second, or third place teams shall advance to state level competition There will be eight (8) Class 1A sectionals, nine (9) Class 2A sectionals, and nine (9) Class 3A sectionals.
Rationale	The first, second, and third-place sectional teams in each class shall advance to state level competition. In Class 1A, the top eight individuals not on the first, second or third place teams shall advance to state level competition. In Class 2A and 3A, the top five individuals on the first, second or third place teams shall advance to state level competition Over the last three years, the Class 1A field size has had fewer full teams competing. The Committee feels that reducing the number of sectionals would standardize the field size by increasing the number of full teams in each sectional. Increasing the additional qualifiers would help keep the total number

The approximate number of full teams for 2017 2A and 3A was 107 girl teams and 116 boy teams.

Discussion Topics

- 1. Discussed shortening the cross country season. While the Committee understands the issues that overlapping seasons has, they feel that this is a problem that must be addressed by each district. The IESA sets the schedule and each school/district/coach must set a policy to address the needs/interests of their students. The Committee encourages districts/schools/coaches to find a workable solution for their students.
- 2. Regular season course markings. The Committee suggested that the NFHS specifications regarding course markings be included in the Cross Country activity update and also in the sectional host instructions.
- 3. The Committee would be interested in the thoughts of the Board regarding the development of a host rotation schedule. This would mean keeping certain schools together year-after-year.
- 4. The Committee briefly discussed four classes of the activity. No recommendation was made.
- 5. Discussion of host expenses and financial reimbursement.
- The Committee discussed the option of holding exhibition races after the sectional races. ADMINISTRATOR RECOMMENDATION: Additional unauthorized timed or un-timed races are not permitted prior to the conclusion of the awards ceremony the day of the Sectional Meet. (Administrative staff in favor.) APPROVED BY BOARD
- 7. Develop a class rotation survey. The Committee would like to gauge the interest of the participating schools in rotating the class race schedule at the state meet.
