The IESA Scholastic Bowl Advisory Committee, in its meeting of May 31, 2018, makes the following recommendations to the Board of Directors for their June 15, 2018 meeting:

## 1. Terms and Condition Changes

## **Recommendation 1**

**Current:** Schools must compete in a minimum of 3 scholastic bowl contests using IESA rules. **Proposed:** Schools must compete in a minimum of 5 scholastic bowl contests against 3 different teams in order to be seeded based on winning percentage. If they do not meet these criteria they will be seeded last. **Rationale:** The committee feels that schools who compete in only 3 matches are often seeded ahead of schools who play more matches since seeding is based on winning percentage. Schools that play the minimum of 3 matches often play the same 2 or 3 schools.

## **Recommendation 2**

**Current:** Scorers and timers are paid \$5.00 per match for the state series.

**Proposed:** Scorer and timer pay should be increased to \$10.00 per match for the state series.

**Rationale:** Most scorer and timers are using a lockout system and are extremely busy during the match, they play an important role in how a match is run.

# **Recommendation 3**

**Current:** Rule 7.d-Communication-A "wait" gesture, from a team captain, that silently communicates to the team to not trigger the lockout system during the second reading of a toss-up question is considered an acceptable form of communication.

Proposed: Remove from legal communication and put it in illegal communication.

**Rationale:** The committee feels that this is not an acceptable form of communication and can be used to gain an advantage.
