The IESA Chess Advisory Committee, in its March, 2022 meeting, makes the following recommendations to the IESA Board of Directors for their April 2022, meeting:

#### **Recommendation 1- Rulebook**

15-2-1 replace 16-3-3 with 11-1, 12-1 and 12-7

15-2-3 add except in **11-1** 16-2 add reference 12-1

### **Points of Emphasis**

- 1. The Greater Peoria Chess Foundation has graciously agreed to provide the boards and pieces for all rounds of play for the 2023 Chess State Tournament.
- 2. Spectator etiquette.
- 3. The tournament format- two day event with players participating in all 8 rounds.

#### **Discussion Topics**

- 1. Discussed the possibility of pairing students who have received byes/forfeits with another student who finishes early. No recommendation.
- 2. Discussed time schedule and format. There was some feedback regarding the length of time between rounds and the number of rounds. With our numbers still recovering from COVID, the Committee did not feel that changes were warranted. They will continue to keep an eye on the time schedule. The Committee advised that all age divisions play the same number of rounds despite the disparity in the number of participants in a given age division.
- 3. Discussed spectators in the playing area. No recommendation.

- 4. Discussed allowing coaches on the playing floor during competition. No recommendation
- 5. Discussed the possibility of having the score tables use Chromebooks. No recommendation.
- 6. Discussed recycling at PCC. Administrator to discuss with venue for both competition room and skittles. Also discuss the frequency of trash removal during the tournament.
- 7. Discussed additional activities to keep the kids busy during their down-time. No recommendation. These additional activities should be coordinated by the coaches.
