 The said school will pay the said official the amount stated above for his services, provided that the obligation of the school ceases if and when the official ceases to be a registered official or if the contest is cancelled because of an epidemic or similar emergency. If a contract is made during a given school year for a contest to be played during the next school year and if, in the meantime, there is change in the school principalship, the contract is valid only if and when the incoming principal has been notified of the existing contract and he has sanctioned it or has failed to inform the official of cancellation within one week after the notification. If either party hereto fails to fulfill the obligation of any part of the contract, that party shall pay to the other party a sum equal to the contractual gross fee less mileage allowances as damages, the remainder of the contract shall not be binding, and the breach of contract shall be reported to the Association. Services provided by the Official are as an independent contractor and not an employee of the Illinois Elementary School Association or the school. The following fee schedule should be followed for postponed or suspended contests: a. If an official is notified of the postponement/suspension of the contest before arriving at the site, no game fee is given. b. If an official arrives at the site and the contest is suspended/cancelled before it begins, the official will receive a show-up fee which is one-half of the game fee. c. If the contest is started, then is suspended and rescheduled. The officials will receive a full fee for the started game and then a full fee for the completion of the game on the rescheduled date. 6.
