# 2017-18 IESA SPEECH ADVISORY MEETING

# Minutes and Recommendations January 10, 2018

The IESA Speech Advisory Committee, in its meeting on January 10, 2018, makes the following recommendations to the IESA Board of Directors for their January 19, 2018, meeting:

### Recommendation 1- By-laws and Terms and Conditions

**Current** Chorale groups of nine to twenty (20) members must present two or more selections within the time

limitation. Groups, except those with only fifth and/or sixth grade contestants, may not be conducted by the speech instructor. Failure to present at least two or more selections, to have the correct number of contestants, or a group that is conducted by the speech instructor shall result in the chorale presentation not being judged or rated. Selections may still be performed at the discretion of

the instructor.

**Proposed** Chorale groups of nine to twenty (20) members must present one or more selections within the time

limitation. Groups may not be conducted (provided performance cues) by the speech instructor with the exception of those with only fifth and/or sixth grade contestants. Failure to have the correct number of contestants, or a group that is conducted by the speech instructor shall result in the chorale presentation not being judged or rated. Selections may still be performed at the discretion of

the instructor.

**Rationale** Many large group scripts are available to perform and meet the time requirement without

supplementation. This also provides a general definition as to what constitutes conducting.

**Proposed** Q. May a student or coach ask the judge not to time the introduction?

A. No. Contestants shall be timed from the first spoken word or stage movement. Introductions are

not required.

# Recommendation 5- By-laws and Terms and Conditions

**Current** Prompting will be permitted in scripted events. The contestant shall be graded down on the

adjudication sheet. If the judge concludes there is excessive prompting, the contestant shall be

lowered one division in the final rating.

**Proposed** Prompting for lines will be permitted in scripted events. If the judge concludes there is excessive

prompting, the contestant shall be lowered one division in the final rating.

**Rationale** Changed wording so that scripted performances were not automatically lowered for receiving a vocal

prompt.

#### **Recommendation 6- Assignments and Host Rotation**

**Current** Current areas

**Proposed** Introduction of new contest area groupings

**Rationale** Some of the areas are becoming too big to manage. So, the contest area assignments were evaluated

and, in some cases, reworked. This also necessitated a change in the host rotation schedule. The new

area assignments and host rotation schedule would become effective for the 2019 season.

# **Points of Emphasis**

- 1. Participating schools should communicate to their hosts as early as possible any changes to their entries. This would include letting their host know if they are using "empty" or blank entry spots.
- 2. Reminder that oral comments may or may not be given by the judge. Coaches should make sure that their kids are prepared for either possibility.
- 3. Team Improv games will be the same as 2017. Please review the guidelines for Team Improv and Invention.
- 4. There will be new contest areas and host rotation schedule for 2019.

#### **Discussion Topics**

- 1. Discussed the performance of multiple selections in Chorale. Multiple selections performed do not have to be separate. Pieces may be interwoven as a part of a theme.
- 2. Discussed introductions. Introductions are not required. The Committee recommends evaluating a performance's time when making a decision regarding including an introduction. If the judge asks for the names of the performers prior, this should not be included in the performance time.
- 3. Discussed increasing the number of Judges' Choice winners per judge based on total contest entries. No recommendation.
- 4. Discussed how hosts should handle "empty" events when scheduling. The Committee recommended that hosts contact those schools with empty events prior to making the schedule to see if they would be using those events. Hosts should schedule some of the "empty" events to accommodate any late changes.
- 5. The Committee recommended adding to the Improv/Team Improv adjudication forms information regarding the distribution of the performance time. This is to serve as a general guide for judges when administering the events.
- 6. ADMINISTRATOR RECOMMENDATION: Introduction of a Lifetime Service Award to be later renamed the Ken Bradbury Service Award. Inaugural recipient- Ken Bradbury. (4-0 in favor), Board Approved
- 7. The 2018 Team Improv games will remain the same as 2017.
- 8. The Committee encourages hosts to secure judges as early as possible.
- 9. To include in the host material: no one (even coaches) are allowed in and/or out of a performance room during a performance; Team Improv information should be distributed to those judges adjudicating those events.
- 10. To include in the judge material: oral comments, if presented, should be as positive as possible. All comments/critiques should justify the given rating.
