# 2019 IESA CROSS COUNTRY ADVISORY MEETING

# Minutes and Recommendations November 18, 2019

The IESA Cross Country Advisory Committee, in its meeting on November 18, 2019, makes the following recommendations to the IESA Board of Directors for their January 31, 2020, meeting:

# Recommendation 1- By-laws and Terms and Conditions and Host Instructions

Current

**Proposed** The Sectional course should be made available to participating schools no less than one hour prior

to the designated start time of the first race.

**Rationale** Participating schools may be new to the sectional course and have an expectation that they will

be able to walk/tour the course prior to the meet to help their participants feel comfortable with the layout. Host schools who are hosting other meets or activities on the course prior to their first sectional race must take this <u>recommendation</u> in to consideration when requesting to host

an IESA Sectional meet.

**Board Action** Passed

#### **Recommendation 2- Terms and Conditions and Host Instructions**

**Current** Host schools will be able to request reimbursement of allowable expenses up to \$1000. To

receive reimbursement, host schools must complete and return the Reimbursement Form with required documentation. Participating schools will not be assessed on a per-team basis to cover deficits of a sectional meet. There is no admission fee for spectators at the sectional meet.

**Proposed** Host schools will receive \$1000 to assist with the expenses of the sectional meet. Host schools

will be sent \$1000 prior to the sectional meet from the IESA Office. Within seven days of the sectional meet, host schools must complete and return the Financial Report Form with required documentation. Participating schools will not be assessed on a per-team basis to cover deficits of

a sectional meet. There is no admission fee for spectators at the sectional meet.

**Rationale** This would allow host schools to pay the race management or timing companies in a timely

fashion.

**Board Action** Passed

#### **Discussion Topics**

- 1. Discussed moving the cross country state series earlier in the season. No recommendation was made.
- 2. Discussed increasing the state series roster size to 12. No recommendation was made.
- 3. Discussed the language regarding uniforms. Information regarding uniforms included in the NFHS Rulebook will also be included in the Terms and Conditions.

- 4. Reviewed the changes made to the Sectional awards- no team ribbons and individual medals. The feedback was positive regarding the changes made in 2018.
- 5. Discussed various advancement proposals- additional teams advancing in sectionals with state team placers in the previous year, developing a time standard for qualification. No recommendations were made. The Committee concluded that with such variation in courses a time standard would be impossible to develop. Also, the Committee acknowledged that the purpose of the state series is not to advance the fastest runners/teams, but to advance the fastest runners/teams from the geographic regions of the state.
- 6. The Committee will conduct a survey to gather information regarding alternate sectional days. See survey questions below. Survey will be accessed when entering 2020 Sectional Participants.
- 7. The Committee discussed future expansion possibilities for the activity. A four class system of the activity was discussed. A two class system with a regional, sectional and state level was also discussed. Splitting the three classes by a 40/30/30 percentage was discussed. No recommendation was made. The Committee felt that the current format is consistent and fair.
- 8. Discussed moving the State meet to a course that could accommodate more runners. There is concern regarding continued changes being made to the current course.
- 9. Discussed posting the complete results and final team standings prior to the awards ceremony at the state meet. No recommendations were made about changing the current procedure. The Committee would like to emphasize to those attending the state meet awards ceremony that they should exhibit proper etiquette and good sportsmanship and not leave the stands until the entire ceremony has concluded.
- 10. Discussion of host expenses and financial reimbursement. No recommendation was made. The Committee did not feel that an additional assessment by the host was needed or acceptable. They would like to continue to monitor the expense reports to see if adjustments need to be made to the total reimbursable amount.

Jake Norman, Shane Orlow and Dave Stier were thanked for their service to the Association, the Committee and the participating schools.
