### Recommendation 1: Girls Wrestling Season Schedule

## **Recommendation 2: Weight Classes**

Proposed: 15 weight classes

65, 70, 76, 82, 89, 96, 103, 111, 120, 130, 140, 151, 165, 185, 235

Rationale: After reviewing other associations and organizations, the committee believes the weight classes listed above are well represented and will help maximize participation. Multiple girls' tournaments across the state have already used these proposed classes and have received positive feedback.

## **Recommendation 3: Sectional Tournament**

Current: N/A

Proposed: Sectionals will be conducted with the potential of a two-day tournament starting on Friday and ending on Saturday. Once a Sectional has been determined to have a Friday start, all participants in all weight classes must be present on Friday to weigh in. There shall be only one weigh-in period for the sectional. Two-day sectional weigh-ins will be held on Friday, and one-day sectional weigh-ins will be held on Saturday. A Friday start will be determined at the conclusion of the Sectional seed meeting if any weight class bracket has 17 or more participants. The bracket size of each weight class will determine how many rounds must be completed in each individual weight class on Friday. If there is a Friday start time, any weight class containing a preliminary round and a quarterfinal round must wrestle on Friday. Saturday will begin with consolation matches.

Rationale: Per NFHS rules, no athlete may wrestle more than six matches in a single day. To remain at or below this limit, the maximum bracket size is 16. Once a tournament has begun, all weight classes must complete weigh-ins on the same day. Having this format would allow for more wrestling to those who weighed in and could make for a shorter Saturday.

#### **Recommendation 4: Sectional Seeding**

Current: N/A

Proposed: In order to be seeded, a wrestler must have at least eight (8) matches completed. Eight contestants in each weight class shall be seeded from entries on the Regional Entry Form in the following manner:

- a) Head-to-head
- b) Common opponents
- c) Overall record at any level regardless of weight class or division. (varsity, sub-varsity, exhibition, j.v, or boys etc.).
- d) Vote by the coaches if the eight seeds cannot be determined through steps a through c above.

Rationale: Keeping the format consistent with the boys' criteria ensures smoother management of sectional seeding. The only difference is in item (c), where "Varsity" has been removed and replaced with the overall record, regardless of the level at which the athlete wrestles. Since all matches count toward the 42-match limit, the committee believes that, at this time, all girls' matches should be included for seeding purposes. This approach provides hosts and coaches with more complete information about each participant during the seeding process.

## **Recommendation 6: Schedule Deadline**

Proposed: Each school must enter 3 meets in which their girls will be competing by the season-schedule deadline of December 7, 2026.

Rationale: The season schedule deadline encourages schools to enter meets on the schedule to increase participation and support the seeding process at the end of the year. The committee recognizes that, initially, scheduling girls-only events may be challenging, as participation levels are still unknown in many parts of the state. This recommendation reduces pressure on schools in areas with lower participation while still encouraging them to seek opportunities at boys' meets where girls will be present and competing.

### **Recommendation 1: Girls Wrestling State Series**

Proposed: The schedule would align with the boys' state series.

Rationale: This will make it easier for wrestling coaches to manage both programs by keeping dates and practices consistent. Since the boys and girls state tournaments will be held together, aligning the schedules ensures consistency and should minimize conflicts. One of the possible differences is a Friday and Saturday Sectional. Depending on bracket size within each weight class and sectional, (which will be known after the roster deadline on Tuesday, March 2) there could be a Friday start and a Saturday finish to a sectional.

## Recommendation 3: State series format

Proposed: Sectionals and state would run as a true wrestleback (same as boys in sectionals).

Rationale: Keeping the format consistent with the boys ensures smoother management of sectionals and state, making TrackWrestling more efficient for both the tournament operator and the software.

#### **Recommendation 4: State series format**

Current: N/A

Proposed: 4 Sectionals and a state tournament. Sectionals and state would run as a true wrestleback (same as boys in sectionals and state). Each sectional would produce 1 team winner awarded with a sectional championship plaque. The top 3 individuals would be medaled in each weight class at each sectional. At the state tournament 4 teams would be awarded trophies, with the top 6 in each weight class being medaled.

Rationale: Keeping the format consistent with the boys ensures smoother management of sectionals and state, making TrackWrestling more efficient for both the tournament operator and the software. Awards at sectionals and state mirrors the boys' format to ensure consistency and fairness. It simplifies tournament operations and maintains competitive standards by awarding a team champion at each sectional and the top 3 individuals being medaled in each weight class, and the top 4 teams at state and the top 6 individuals being medaled per wight class

#### **Recommendation 5: State series entries**

Proposed: Each entered team into the sectionals would be able to enter 1 wrestler per weight class.

Rationale: Limiting entries to one wrestler per weight class per team provides better control over the currently uncertain numbers. This approach allows sectionals to maintain more predictable weight class sizes compared to permitting two entries per class.

### **Recommendation 6: Weight Classes**

Proposed: 15 weight classes for the Girls Wrestling State Series.

Rationale: This number was settled on by research into local club policies and other middle school girl state tournaments along with surveys the IESA has done on participation and weight classes. Each weight class among the 15 has not been finalized to date.

### **Recommendation 7: State qualifiers**

Current: N/A

Proposed: Sectional qualification in each weight class would qualify 3 individuals for the state tournament. This would send 180 girl wrestlers to the state tournament.

Rationale: Advancing the top three wrestlers in each classification ensures that the strongest competitors qualify for the state tournament, maintaining the right balance between participation and high-level competition.

### **Recommendation 8: State Tournament Schedule**

Current: N/A

Proposed: The state tournament would run concurrently with boys in a 2-day tournament.

Rationale: With our current state venue at NIU, we have the capacity to place 8 mats on the floor. This setup allows us to run the girls' and boys' state tournaments concurrently under the proposed 15 weight classes and 180 qualifiers. By doing so, we can avoid adding an additional day to the tournament, which significantly reduces expenses related to officials, athletic trainers, and other



venue costs. Other options will need to be explored as girls wrestling grows. The detailed tournament schedule for the two-day format is still being finalized.

**Other Items discussed:**

- Sectionals run on Friday and Saturday. With numbers being unknown the first few years, brackets could be larger than 16 in each weight class. With this in mind sectional hosts would need to be selected with the understanding that a Friday afternoon start time is possible. This will be known if a sectional must start on Friday after the roster deadline.

- Seeding rules/criteria for sectionals will be established for how seeding would be done at the sectional level. This may be tricky starting out because of the unknown in participation. We have a good idea that parts of the state will not have high numbers in girls wrestling. Seeding criteria has not been finalized.

- Girls wrestling terms and conditions will begin to be established after the board decision on the girls state series.

- State tournament finals on Saturday will have the possibility to run on 6 mats to account for girls wrestling finals. Currently it is on 4 mats for the finals.
